## MSI Global Alliance – Chief Executive of MSI Global Alliance visit in Mauritius

## Legislative Changes in Mauritius – Tax Alert

On the 25th of July 2019, the Finance (Miscellaneous Provisions Act) 2019 was assented. A salient summary of its key amendments are included below:

### Controlled Foreign Company (CFC) Rule

CFC is a company that:

- Is not Mauritian resident;
- More than 50% of its total participation rights are held directly or indirectly by a resident company together with its associated enterprises.
- Includes a permanent establishment (PE) of the resident company.

CFC rules cannot be applied to a CFC where in an income year:

- Accounting profits < EUR 750,000 and non-trading income < EUR 75,000.
- Accounting profits < 10% of its operating costs of the tax period; or
- The tax rate in the country of residence of the CFC is > 50% of the tax rate in Mauritius.

### Partial Exemption Regime:

The 80% partial exemption regime has been extended to cover the following (subject to satisfying certain conditions):

- Leasing and provision of international fibre capacity;
- Insurance and reinsurance brokering activities; and
- Sales, financing arrangements and asset management of aircraft and its spare parts (includes aviation related advisory services)

### Freeport:

As from the 1st of July 2020, freeport operators or private freeport developers who manufacture goods will be liable to a tax rate of 3% from export sales (provided certain substance conditions are satisfied). Sale of goods on the local market remains taxable at 15%.

## International Compliance Update

On the 23rd of August, the Asia-Pacific Group (APG) of the Financial Action Task Force has put Pakistan on the "Enhanced Expedited Follow Up List" after it failed to convince the 41 plenary members that it took concrete and verifiable action against funding of terrorism. We remind our readers that Mauritius continues to be a compliant, secure and safe business and investment destination, as highlighted by the ESAAMLG's (Eastern and Southern Africa Anti-Money Laundering Group) latest mutual evaluation report. In the document, Mauritius is shown as being largely compliant with respect to the 40 recommendations of the Financial Action Task Force.
